Thank you for your support of the Mississippi Kidney Foundation, Inc.'s Car Contribution Program. Your gift will help in the fight against kidney disease. Donating your vehicle to the Mississippi Kidney Foundation is a **simple** process.

1. RETURN PAPERWORK

Please return:

- **completed Donor Information Sheet** (enclosed)
- **completed Tax Information Form** (enclosed)
- **signed title** (sign your name on the back, in the space provided for the "seller" or "transferor" under the "Assignment of title by Registered Owner" section.)
Name on front of title must be the same as name of donor.

2. FREE TOWING

After we receive your signed title, we will arrange for free towing. In most cases the vehicle can be picked up within several days, but occasionally it may take longer. The vehicle **MUST** be located on the street, in the driveway or in a location where the tow truck can **EASILY** reach it for hook up. **(Please remove the license plate and all personal articles before pick-up.)**

Effective January 1, 2005, the tax laws concerning vehicle donations changed. In an effort to try to explain these changes as simply as possible, we have compiled the following information.

\$500 or less

- **If the donor claims a tax deduction of \$500 or less, the Kidney Foundation will furnish the donor with a letter acknowledging the donation.**

\$501 or greater

- **If the donor intends to claim a tax deduction of \$501 or greater, the Kidney Foundation will provide the donor with the "gross sale price" after the vehicle is sold at auction. That "gross sale price" is the amount of deduction that the donor is allowed to claim. *Additionally, for tax purposes, the donor must provide the Kidney Foundation with his/her social security number.***

Note: Typically, the sales prices at auction are less than that of private party transactions. This is due to supply and demand and other factors.

How to Donate Your Boat/Motor/Trailer

1. RETURN PAPERWORK

Please return:

- **completed Donor Information Sheet** (enclosed)
- **completed Tax Information Form** (enclosed)
- **completed Deed of Gift Form** (enclosed)
- **Title** (If the boat has ever been titled, please sign the title on the back in the space provided marked "seller or "transferor").

2. FREE TOWING

After we receive the completed forms and other papers, we will make arrangements for the towing company to pick up your vehicle. All personal articles should be removed before pick-up.

Effective January 1, 2005, the tax laws concerning vehicle donations changed. In an effort to try to explain these changes as simply as possible, we have compiled the following information.

\$500 or less

- **If the donor claims a tax deduction of \$500 or less, the Kidney Foundation will furnish the donor with a letter acknowledging the donation.**

\$501 or greater

- **If the donor intends to claim a tax deduction of \$501 or greater, the Kidney Foundation must provide the donor with the "gross sale price." That "gross sale price," which is the amount that the vehicle sells for at auction, will determine the deduction that the donor is allowed to claim. *Additionally, for tax purposes, the donor must provide the Kidney Foundation with his/her social security number.***

Note: Typically, the sales prices at auction are less than that of private party transactions. This is due to supply and demand and other factors.
